Climbing Escalade Canada (CEC) is seeking qualified candidates to sit on our Competition Committee. The committee will report directly to the CEC Board and will be responsible for ensuring that competitions follow all CEC Rules and Regulations, as well as ensuring that National level events are run according to CEC standards.

The positions are as follows:

Chair

This person will be responsible for coordinating all sub-committees and for creating timelines. The chair will attend CEC Board meetings as a non-voting member, as required, to report to the Board on behalf of the Competition Committee (CC). The chair will be an ex officio member of all sub-committees.

Qualifications –

- Extensive knowledge of competition climbing
- Works well in a team environment
- Able to provide direction to the sub-committees
- Full understanding of CEC Rules and Regulations
- Highly organized

Competition Committee (CC)

Role of the CC:

The CC is a consultative, non-voting committee comprised of experts in competition organization, route setting and the technical aspects of competition climbing. The committee works collaboratively, and maintains a global perspective towards optimal development of the discipline across Canada, in line with the CEC strategic plan and corporate goals. The committee advises and assists the CEC Board in the following areas:

- Setting goals and objectives that contribute to the long-term success of competition climbing in Canada, while respecting the principles of LTAD
- Developing and implementing multi-year plans
- Developing technical programs and regulations, selection processes, practices and procedures
- Supporting the CEC Board of Directors in the development and implementation of program initiatives
- Assisting with other matters brought forward by the CEC Board of Directors

Composition of the CC

- Chair
- 2 members from each sub-committee

Term of Office for Committee Members

- The term of office shall be through June 2019. There is no limit to the number of consecutive terms
- Representative must be active in the climbing community

Technical Sub-Committee (TSC)

Role of the TSC:

- To establish a master plan for the training and recruitment of officials (judges and technical delegates), up to and including National development
- To plan judges' clinics, courses, schools and supervise the certification of officials (Judges and Technical Delegates)
- To distribute information and literature on judging, rules, and field of play regulations to officials
- To maintain an up-to-date record of the participation and rating of all officials
- To be responsible for the National assignment of officials
- To provide information and technical advice to the CEC Board

Composition of the TSC

- Chair
- Members are to be made up of competition organizers, jury presidents, judges, technical delegates and members at large with technical knowledge from other sports.

Term of Office for Committee Members

- The term of office is through June 2019. There is no limit to the number of consecutive terms.

Event Sub-Committee (ESC)

Role of the ESC:

- To establish a master plan for the National Series competition schedule, up to and including Youth and Open Nationals
- To review the current National Series and make recommendations to the Board on areas of improvement, including possible format changes
- To distribute information and literature on competitions, formats, policies, rules, and field of play regulations to host facilities
- To order and distribute competition package to host facilities, including medals

- To be responsible for National Series hosting assignments, including the development of the application package and minimum requirements

Composition of the ESC

- Chair
- Members are to be made up of competition organizers, gym owners and managers and route setters

Term of Office for Committee Members

- The term of office is through June 2019. There is no limit to the number of consecutive terms.

Route Setting Sub-Committee (RSSC)

Role of the RSSC:

- To establish a master plan for the training and recruitment of route setters, up to and including National development
- To plan route setting clinics, courses, schools and to supervise the certification of route setters
- To distribute information and literature on setting, rules, and field of play regulations to route setters
- To maintain an up-to-date record of the participation and rating of all route setters
- To be responsible for the assignment of National route setters
- To provide information and technical advice to the CEC Board

Composition of the RSSC

- Chair
- Members are to be made up of route setters.

Term of Office for Committee Members

The term of office is through June 2019. There is no limit to the number of consecutive terms.
